Call to Order:

 - Reykjavik, Iceland April 10-17, 2021

Sandra Vermeulen, high school Environmental Science Teacher, presented information regarding a planned trip to Iceland in April of 2021. The trip will focus on exploring the geothermal wonders of Iceland, including the Blue Lagoon hot springs, volcanic craters and subarctic fauna.

A motion was made by Ms. Harrigan to approve the trip and move the trip for consideration to the full board of education. The motion was seconded by Mr. Perugini. The motion passed unanimously (Ms. Ham, Ms. Harrigan, and Mr. Perugini).

 - Excellent Adventures A Microsoft Excel Simulation

 Leslie Paier, High School Business Department Chair, presented on efforts to include Microsoft Office Suite, specifically skills in Excel, into the Computer Essentials Course.

c. Overview of Veterans Day Activities

Marlene Silano, Assistant Superintendent of Schools, shared a presentation that captured each school's events, happenings, and efforts to honor Veteran's Day. As part of the veterans visiting each school, some of those happenings included: Veteran's breakfasts, patriotic music (including an original song), stations to explore military equipment, honor walks and assemblies, cards and appreciation letters, veteran profiles/introductions, and panel discussions

• Math Night/Math Strategies 7 Sessions

Kevin Hanlon presented on two fall parent meetings: English Learner (EL) Parent Night and Math Parent Informational Night.

The EL parent night was focused on helping parents understand the process for EL identification, monitoring growth, and exiting the program; what EL support looks like in the classrooms; and key people for parents to know.

The Math parent night was designed as part of an ongoing effort to help connect families to their child's math instruction. Parents chose three out of a total of seven possible sessions each focused on a different set of visual math strategies at various grade levels. Online video clips that mirror the presentations are in development, will be added to the district website, and will be sent out to families later this winter
