3. <u>DISCUSSION/ACTION REGARDING THE 2023/2024 SUPERINTENDENT'S</u> <u>RECOMMENDED BUDGET.</u>

Mr. Grippo explained that over the course of the last three budget meetings, they have reviewed certified and non-certified salaries, employee benefits, instructional expense, support services and maintenance and operations. The Superintendent has asked for a budget increase of \$5,208,171, which is a total increase of last year's approved budget at 6.46%. He said the Finance Committee will make a motion and if approved, it will be brought to the full Board of Education.

MOTION by Mr. Grippo and seconded by Ms. Rosenberg.

MOVED that the Finance Committee approve a budget of \$85,872,591, which is an increase of \$5,208,171 or 6.46%. for the 2023 2024 budget.

Discussion:

Board members asked for clarification on a few budgeted accounts. Mr. Masciana and Dr. Solan answered their questions.

VOTE: The Motion passed unanimously by those present.
